SUBJECT: TERMINATION OF THE JOINT SHARED SERVICES TRANSACTIONAL
CENTRE SECTION 22A COLLABORATION AGREEMENT

1. The Joint Shared Services Transactional Centre Section 22A Collaboration Agreement expires 30 September 2025.
2. The functions and responsibilities of the Joint Shared Services Transactional Centre are now undertaken by the Joint Finance Department and the Joint People Directorate and are incorporated into these agreements.
3. In accordance with Section 8, the request for immediate termination of the of the Joint Shared Services Transactional Centre Section 22A Collaboration Agreement is presented for PCC consideration and approval.

It is recommended that the Chief Executive of the Office of the Police and Crime Commissioner is authorised to execute the Agreements to Collaborate (under Section 22A of the Police Act 1996).

DETAIL OF THE SUBMISSION

1. KEY ISSUES FOR CONSIDERATION:

- 1.1 Termination of the Joint Shared Services Transactional Centre Section 22A Collaboration Agreement is requested by the Norfolk and Suffolk Chief Constables and OPCCs in accordance with Section 8 of the Agreement.
- 1.2 Norfolk and Suffolk Chief Constables and OPCCs agreed to collaborate under a Section 22A agreement with a Joint Shared Services Transactional Centre Section in October 2020 in the interests of efficiency and effectiveness.
- 1.3 Following review and restructure, the functions and responsibilities of the Joint Shared Services Transactional Centre have moved and are now undertaken by the Joint Finance Department and the Joint People Directorate. The agreements for these existing joint units have recently been updated to reflect the changes.
- 1.4 The basis of the Joint Shared Services Transactional Centre Section 22A Collaboration Agreement no longer exists and it can therefore be terminated forthwith.
