

VICTIMS' COMMISSIONING

The PCC receives funding from the Ministry of Justice (MOJ) for the purposes of commissioning victims' services - including child sexual abuse, domestic abuse, and sexual violence. For 2025/26, we used MOJ and PCC funding to commission the following services for victims:

Suffolk	All Crime Types	Norfolk & Suffolk Victim Care Service (NSVC)	Free and confidential support is available to all victims and witnesses of crime, regardless of police involvement. Services are offered to adults, children, and young people, including guidance through the Criminal Justice System. Jointly commissioned by the Norfolk and Suffolk PCCs the service accepts self-referrals, third party and police referrals with informed consent. The service was delivered by Victim Support until 30 September 2025 and included specialist support for standard-risk domestic abuse victims. 		The Restorative Justice (RJ) Hub	Restorative Justice (RJ) is a victim-focused process that facilitates communication between those harmed by crime or conflict and those responsible. 	Domestic Abuse (High Risk)	Independent Domestic Violence Advisory (IDVA) Service	The Suffolk IDVA Service supports high-risk domestic abuse victims from police report to court.
