#### SUMMARY:

- 1. The Police and Crime Commissioner can commission services that:
  - a) secure, or contribute to securing, crime and disorder reduction in Suffolk;
  - b) are intended to help victims or witnesses of, or other persons affected by, offences and anti-social behaviour.

This is in accordance with the provisions in the Anti-Social Behaviour, Crime and Policing Act 2014. In applying this provision, the PCC will ensure that the services commissioned are also consistent with the Suffolk Police and Crime Plan 2017 – 2021.

- 2. This report seeks approval to award of a grant to Compassion for the amount of £20,000 to continue the forum activities supporting victims of domestic abuse for the period 1 April 2017 to 31 March 2018.
- 3. The funding will support the Police and Crime Plan objective to ensure the provision of high quality services to victims of domestic abuse.

#### RECOMMENDATION:

1. It is recommended that the PCC approves a grant of £20,000 for the period 1 April 2017 to 31 March 2018 to Compassion to deliver services to victims of domestic abuse.

#### **DETAIL OF THE SUBMISSION**

#### 1 INTRODUCTION

- 1.1 The Police and Crime Commissioner can commission services that:
  - a) secure, or contribute to securing, crime and disorder reduction in Suffolk;
  - b) are intended to help victims or witnesses of, or other persons affected by, offences and anti-social behaviour.

This is in accordance with the provisions in the Anti-Social Behaviour, Crime and Policing Act 2014. In applying this provision, the PCC will ensure that the services commissioned are also consistent with the Suffolk Police and Crime Plan 2017–2021.

1.2 This report recommends that the PCC approves a grant of £20,000 for the period 1 April 2017 to 31 March 2018 to Compassion to ensure continued availability of services to victims of domestic violence and abuse in the Babergh area of Suffolk.

#### 2 POLICE AND CRIME PLAN OBJECTIVES

- 2.1 Following the issue of the Police and Crime Plan 2017-2021 work has been on-going to ensure that the Police and Crime Objectives and the Plan's principal themes will be achieved. A key theme within the Plan is ensuring the provision of high quality services to victims of domestic abuse.
- 2.2 The proposed grant will contribute to the Police and Crime Plan by funding core service costs to support the provision of specialist support to victims of domestic violence and abuse.

#### 3 COMPASSION: ADDRESSING DOMESTIC ABUSE IN BABERGH

- 3.1 Compassion is an independent, multi-agency forum that was founded in 2001 and gained charity status in 2014. The forum aims to ensure that victims of domestic violence in the Babergh area of Suffolk have access to community based, locally led, high quality services and programmes. The forum works to raise awareness of domestic violence related issues and help victims break the cycle of abuse through providing programmes and free, confidential support services.
- 3.2 The PCC provided funding to the Compassion in 2014 to increase the organisation's capacity and capability and again in 2016/17 to support the part time project manager post to maintain core programme and service delivery, promoting services and awareness raising with the community and other agencies.
- 3.3 Compassion reported the following outputs and outcomes during 2016/17:
  - 93 people were supported during 2016/17, 12 of whom were supported to report to the police (21% of those who had not reported to the police at engagement);
  - Four safeguarding referrals (women and children) were made;
  - Evaluation indicated the following impact of the services provided in helping clients to cope and recover (based on 39 responses over 9 months of the grant period):

0	Improved understanding of the abuse they have experienced	90%
0	Increased Self Esteem	74%
0	Increased Self confidence	74%
0	Improved support networks	72%
0	Improved health and well being	69%
0	Improved relationships	59%
0	Improved perception of safety	59%
0	Feeling informed	59%

- 3.4 Compassion receives referrals from a range of agencies (e.g. Children and Young People Services, Social Services, Health, GPs, Police, IDVA Service, ACT (DA support service), Schools and Citizens Advice). The service also receives self-referrals.
- 3.5 Compassion is continuing to develop services in Hadleigh and Shotley as currently underserved areas. Whilst direct referrals for men have not been received to date, the organisation is also considering a pilot in the Sudbury area which will consider the best approach for male victims of domestic violence.
- 3.6 A grant award of £20,000 from the Police and Crime Commissioner will allow the Projects Manager post to continue. The post co-ordinates the programmes and services that Compassion runs including: Freedom Programme; Who's in Charge?; Stronger Families; Support Group; One to One support and Befriending.
- 3.7 Extending the part time post from 15 hours a week (as previously funded by the PCC) to 18 hours a week (or nearly 2 extra days a month) will allow Compassion to develop new services and programmes with other agencies and raise awareness with victims and local engagement.

#### 4 OUTPUTS/OUTCOMES

- 4.1 This grant award is made on the basis of financial and activity data being made available on a quarterly basis with a final report submitted to the PCC by 14 April 2018.
- 4.2 Monitoring will report on activity, outputs and outcomes from Compassion's work with clients and practitioners. This will include information relating to where the Project's Manager has facilitated engagement with other funded programmes (e.g. Freedom Programme).
- 4.3 The following outputs and outcomes will be reported on:
  - Number of victims/clients supported by the service overall (and of those how many supported via each service (e.g. Freedom Programme, Befriending, One to One support or in another way)
  - Profile of victims (gender/ethnicity/sexual orientation/age)
  - Extent of geographical provision
  - Number of victims who had not presented to the police at engagement with the service and number supported to report to the police following engagement
  - Numbers of referrals from other agencies, and breakdown by agency, and the number of self-referrals
  - Numbers of referrals and signposting to other agencies, and which agencies
  - Proportion of clients/victims who have presented previously (i.e. repeat users)
  - Breakdown of type of abuse e.g. physical, emotional, sexual
  - Proportion of non-recent cases
  - Number of volunteer hours delivered each month.
  - Number of courses/programmes/sessions to practitioners
  - Details of work with other partners to deliver services
  - Outcomes at closure (e.g. client no longer wanted support, referred on etc.).
  - Number of safeguarding referrals (distinguishing adults from children)

### Outcomes (including cope and recover)

- · Client satisfaction with the service and programmes
- Victim perception of the police and Criminal Justice System
- Client evaluation of the impact of the service (in helping them to cope and recover) including the following indicators to show distance travelled:
  - Increased self-esteem
  - Increased self-confidence
  - Improved understanding of abuse/ the abuse they have experienced
  - Improved relationships (partner/children/parents) e.g. proportion of attendees who feel they are better parents as a result of intervention and can keep their children safer
  - Improved support networks
  - Improved perception of safety
  - Improved access to services (sexual health, emergency health and substance misuse).
  - Feeling informed through increased awareness of services available, victim rights and choices.
  - Increased confidence in criminal justice agencies e.g. police, courts, CPS
  - Feeling supported and informed about developments in their case.
  - Improved health and wellbeing

#### 5 FINANCIAL IMPLICATIONS

- 5.1 The award of this grant mitigates the risk of reduced services for victims of domestic violence and abuse to the most vulnerable victims in the Babergh area.
- 5.2 The grant covers the cost of the part time Project Manager for 12 months and expenses to support the post including travel across the district.
- 5.3 Full conditions of award are contained in Appendix A.

# 6 RISKS

- 6.1 There are no risks flowing from the consideration of this report.
- 6.2 An assessment of risk in delivery of the service has been undertaken. This assessment has considered the value of the grant sought, the duration of delivery and the grant recipient's history of delivery and ability to deliver. The monitoring arrangements outlined in the conditions of award reflect the fact that Compassion have proven service delivery over a period of years and have previously delivered satisfactory monitoring reports to the PCC. Should there be any risk to the service being delivered the grant recipient is required to notify the PCC.
- 6.3 Full conditions of award are contained in Appendix A.

# 7 RECOMMENDATIONS

7.1 It is recommended that the PCC approves a grant of £20,000 to Compassion for the period 1 April 2017 to 31 March 2018.

#### **VICTIMS' SERVICES GRANT 2017/18**

# **CONDITIONS OF AWARD**

### 1. Victims' Services Grant

- 1.1 The Police and Crime Commissioner can commission services that:
  - a) secure, or contribute to securing, crime and disorder reduction in Suffolk;
  - b) are intended to help victims or witnesses of, or other persons affected by, offences and anti-social behaviour.

This is in accordance with the provisions in the Anti-Social Behaviour, Crime and Policing Act 2014.

- 1.2 The PCC's victims commissioning approach will prioritise grant applications which:
  - (a) fulfil the requirement to provide services for victims who are entitled to enhanced services, and
  - (b) address gaps in service provision.
- 1.3 Commissioning decisions will be made on the basis of those which are considered to have the greatest likelihood of delivering the best possible outcome, in terms of helping victims to cope and recover from their experience and take into account the following:
  - Innovation an innovative approach to delivering victims' services;
  - Working in partnership/collaboration working in partnership or collaboration with one or more additional victims' services providers;
  - Hard to reach/hear groups services that are aimed at supporting victims from hard to reach/hear groups;
  - Gaps in services services that will address an unmet need/gap in services.
- 1.4 The Police and Crime Commissioner for Suffolk will award a grant of up to £20,000 to Compassion for the period 1 April 2017 to 31 March 2018 to deliver practical and emotional support to victims of rape and serious sexual offences.

# 2. Conditions of Award

2.1 This award is a one-off award and is made on the basis of delivering the service above (including supporting capacity and capability building, future sustainability of the service and innovation in delivery of the service). The agreement of this award is based on the service a) supporting increased demands and b) improving its sustainability and does not place any ongoing responsibility on the PCC to fund the service beyond the period of this grant.

- 2.2 The award is also made on the basis that the grant recipient uses the grant for the service (as defined at paragraph 1.4 above). In the event that the grant is not used for these purposes the monies must be repaid to the PCC.
- 2.3 The grant must be used to provide services which are free of charge to victims of crime who are entitled to enhanced services.
- 2.4 The grant recipient must comply with the conditions placed upon the PCC by the MoJ grant agreement which includes strict criteria regarding use of the grant and monitoring requirements.
- 2.5 The following costs are not Eligible Expenditure: Payments that support activity intended to influence of attempt to influence Parliament, government or political parties, or attempting to influence to awarding or renewal of contracts and grants, or attempting to influence legislative or regulatory action.
- 2.6 The grant recipient must be able to evidence appropriate safeguarding procedures for those using their services and have due regard for the Local Children Safeguarding Board policies and guidance. The grant recipient must ensure that its services, policies, training, recruitment, vetting and referral processes appropriately safeguard children and vulnerable adults.

# 3. <u>Bureaucracy</u>

3.1 The grant recipient must be able to demonstrate that they are managing the grant in an efficient and effective manner, and are actively seeking to minimise bureaucracy and streamline processes in order to deliver the best possible outcomes.

# 4. Transfer of funds

- 4.1 Payment will be made quarterly following the receipt of an invoice/payment request, and must be accompanied by the appropriate monitoring information.
- 4.2 The grant recipient will invoice the PCC for the grant after which transfer of funds will be arranged within 21 working days of receipt of the invoice.
- 4.3 The PCC will not pay in advance of need. If the PCC reasonably believes that payment is being made in advance of need, the PCC may change the timing and/or the amount of any payments.
- 4.4 In order for any payment to be released, the PCC will require the grant recipient to:
  - have accepted these conditions by signing and returning a copy of this Conditions of Award agreement,
  - have provided a communications plan and agreed publicity for this decision;
  - have provided appropriate bank details, and
  - be in compliance of the terms of award (including the MoJ conditions where appropriate).

# 5 Monitoring

- 5.1 The grant recipient will report quarterly on the specified output and outcome measures as specified in section 4 and on financial expenditure. A final report will be submitted by 14 April 2018.
- 5.3 The PCC may require attendance at a public meeting of the PCC's Accountability and Performance Panel, on dates as determined by the PCC's Chief Executive. If this is the case the Chief Executive will advise the recipient.
- 5.4 The grant recipient must notify the PCC as soon as reasonably practicable if the organisation ceases operation, the project does not proceed or if an underspend is forecast. Any underspend must be returned to the PCC.

# 6. Commissioning Principles

6.1 In the circumstances where the grant recipient commissions services from other bodies applications must be assessed (by the grant recipient) with good practice commissioning principles in mind (e.g. guidance on commissioning issued by the Association of Policing and Crime Chief Executives), and having due regard to equality, diversity and human rights issues.

# 7. Publicity and Marketing

- 7.1 By accepting the award from the PCC the grant recipient makes a commitment to acknowledge the PCC's support publicly and must acknowledge their funding from the PCC in all their promotional work. Any recipients of funding via the grant recipient must display the PCC's logo in all publicity for the life of the initiative. Logo artwork can be provided upon request. Any exceptions must be agreed with the PCC.
- 7.2 The grant recipient will liaise with the PCC's Communications Manager to agree a communications plan, including publicising this funding decision.

### 8. Access to Information

- 8.1 The PCC expects reasonable access to any records and information held by the grant recipient for purposes associated with the award.
- 8.2 The PCC reserves the right to withhold all or any payments of the award if the PCC has reasonably requested information/documentation from the grant recipient and this has not been received by the PCC in the timescales reasonably required.
- 8.3 The PCC expects the grant recipient to be flexible regarding any changes to outcomes recording required by the Ministry of Justice.

# 9. Miscellaneous

- 9.1 The award may not be used to support or promote religious activity. This will not include inter-faith activity.
- 9.2 The grant recipient must ensure that all reasonable steps have been taken to ensure that it and anyone acting on its behalf complies with any applicable law for the time being in force (so far as binding on the recipient).
- 9.3 The grant recipient, and its employees, shall be careful not to be subject to conflicts of interest.
- 9.4 The grant recipient shall ensure that third party recipients have adequate insurance coverage (including but not limited to public liability insurance) in place and shall provide evidence of such insurance to the PCC on request.
- 9.5 The PCC accepts no liability to the grant recipient or third party recipients for any costs, claims, damage or losses, however they are incurred, except for to the extent that they arise from personal injury or death which is caused by the PCC's negligence.
- 9.6 The grant recipient agrees to indemnify the PCC for any costs, claims, damages or losses which arise as a result of negligence by the grant recipient or out of any breach by grant recipient of any of the conditions of award.

# 10. Termination

10.1 This agreement may be terminated by either party giving the other at least three months' notice in writing.

# **ACCEPTANCE OF VICTIMS SERVICES GRANT**

Compassion accepts the offer of an award of £20,000 and agrees to comply with the terms and conditions of the Grant on which the offer is made (including the MoJ conditions in their grant agreement).
