<p>SUMMARY:</p> <ol style="list-style-type: none"> In accordance with the provisions in the Anti-Social Behaviour, Crime and Policing Act 2014 the Police and Crime Commissioner can commission services that: <ol style="list-style-type: none"> secure, or contribute to securing crime and disorder reduction in Suffolk; are intended to help victims or witnesses of, or other persons affected by, offences and anti-social behaviour. In applying this provision, the PCC will ensure that the services commissioned are consistent with the Suffolk Police and Crime Plan 2017-2021. This report seeks approval to award a grant to support participation in 'KickOff@3' in Suffolk. The funding will support delivery of Objectives 2 and 3 in the Police and Crime Plan through supporting young people through positive engagement and encouraging engagement with and across diverse communities.

DETAIL OF THE SUBMISSION

1. INTRODUCTION

- 1.1 In accordance with the provisions in the Anti-Social Behaviour, Crime and Policing Act 2014 the Police and Crime Commissioner can commission services that:
- a) secure, or contribute to securing, crime and disorder reduction in Suffolk;
 - b) are intended to help victims or witnesses of, or other persons affected by, offences and anti-social behaviour.
- 1.2 In applying this provision, the PCC will ensure that the services commissioned are also consistent with the Suffolk Police and Crime Plan 2017 – 2021.
- 1.3 This report seeks approval to award a grant of up to £2,000 to support the KickOff@3 event in Suffolk in 2019.

2. POLICE AND CRIME PLAN OBJECTIVES

- 2.1 The proposed grant is intended to contribute to the delivery of the Police and Crime Plan 2017-2021 Objective 2 (Caring about victims, communities, the local economy and our people) and Objective 3 (Protecting the most vulnerable people and communities by preventing, reducing and solving crime and anti-social behaviour).
- 2.2 The proposed grant will support delivery on identified Police and Crime Plan actions through:
- Caring about young people - supporting young people through positive engagement schemes;
 - Caring about our communities - arrangements for engaging with our diverse communities;
 - Tackling Serious Violence - responding to the threats to vulnerable people posed by serious violence and using commissioning powers to invest in voluntary sector initiatives which make a difference in this area.

3. KICKOFF@3

- 3.1 KickOff@3 was launched in 2017 by Met Police officer Michael Wallace and community worker Ashley Levien to encourage positive engagement, break down barriers through sport, raise aspirations and increase cohesion. The aim of the initiative is to provide diversionary activity for young people, positive youth engagement and promote health and well-being in youngsters whilst supporting a local charity.
- 3.2 In 2018 Suffolk Constabulary applied to participate in the national initiative and run Suffolk KickOff@3 in April 2019. The PCC supported the launch of KickOff@3 in January 2019, led by Suffolk Constabulary in partnership with Ipswich Borough Council, Suffolk County Council, Suffolk Football Association, Suffolk Positive Futures and other local organisations.

3.3 The event in Suffolk will offer young people, between the ages of 13 and 16, the opportunity to compete in a 7-a-side football tournament, win prizes and recognition locally. The tournament is open to girls and boys and mixed teams with the winners of each age category competing against the winners from other parts of the country in a finale event in London on 7 July 2019. More information is available at Appendix A.

3.4 The event will promote:

- Positive engagement with young people in Suffolk whilst breaking down barriers through sport
- Community cohesion through the community event and activities running alongside the tournament;
- Awareness of charitable needs, with the local event raising funds for YMCA Trinity Group;
- Positive collaboration to provide diversionary activity for young people, raising aspirations through highlighting career opportunities, volunteering and work experience opportunities;
- Trust and confidence with local community groups and increased engagement between the police, statutory agencies and charities with the diverse communities in Suffolk.

4. MONITORING AND OUTCOMES

4.1 This grant award is made on the basis of financial and activity information being made available to the PCC by 30 August 2019. The PCC would expect this to include feedback from partners and participants on the difference they think the event has made against the aims outlined in section 3.4 above.

5. FINANCIAL IMPLICATIONS

5.1 Funding of up to £2,000 is requested from the PCC towards the running costs of the tournament and participating in the finals in London. This includes coach travel to the London finals, refreshments, medals and prizes.

5.2 Other partners and sponsors are supporting the event through providing first aiders and through funding the venue, refreshments and the match day programme.

6. CONDITIONS OF AWARD

6.1 The following conditions will apply should a grant be awarded.

- (i) The fund will be allocated to projects, initiatives or events in Suffolk which support the objectives set out in the [Police & Crime Plan](#);
- (ii) All grants are one-off payments that can be used to pump-prime a project or pay for a one-off event;
- (iii) The PCC is not be responsible for any on-going costs associated the project/initiative;
- (iv) In normal circumstances the funding will not be made available to support staff salaries, core business activities, overheads/costs associated with business administration or capital projects of the recipient;
- (v) Projects approved under this process should be completed in the financial year 2019/20 and only in exceptional circumstances will a carry-forward be agreed;

- (vi) The award must only be used for the purpose set out in the application or as approved in writing by the PCC. The PCC must be notified as soon as reasonably practicable if the project does not go ahead, or if an underspend is forecast. All underspends must be returned to the PCC;
- (vii) By accepting the award the recipient makes a commitment to acknowledge the PCC's support publically and must acknowledge the PCC in all promotional work, as well as display the PCC's logo in all publicity associated with the initiative;
- (viii) All recipients of funding will be expected to provide information on outcomes, including a written summary on how the project supported objectives in the Police & Crime Plan. The PCC also reserves the right to hold the recipient to account at the Accountability & Performance Panel;
- (ix) The award may not be used to support or promote political or religious activity.

Recipients of funding will ensure that any data processing that is carried out to deliver the service meets the requirements of the General Data Protection Regulation (GDPR) or other relevant data protection legislation, and further ensure that the rights of the data subject are delivered and evidence compliance if asked to do so by the PCC.

7. OTHER IMPLICATIONS AND RISKS

- 7.1 There are no major implications or risks associated with this decision paper.
- 7.2 An assessment of risk in delivery of the service has been undertaken. This assessment has considered the value of the grant sought, the duration of delivery and ability to deliver.
- 7.3 Should there be any risk to the service being delivered, the Constabulary is required to notify the PCC as per the conditions of award.

8. RECOMMENDATIONS

- 8.1 It is recommended that the PCC approves a grant of up to £2,000 to support Suffolk KickOff@3 2019.
