


Suffolk Police and Crime Commissioner's Fund



HOW TO APPLY



Making Suffolk a safer place to live, work, travel and invest



The Police and Crime Commissioner's Fund is an annual £300k fund that supports the delivery of services that help make Suffolk a safer place in which to live, work, travel and invest.

Grants of £2,500-£20,000 are available to voluntary, community and social enterprise organisations to help deliver Suffolk's Police and Crime Plan, which aims include:

- Vulnerable people and victims of crime
- Serious violence
- Young people
- Drugs and substance abuse
- Preventing reoffending and reducing crime.

The Police and Crime Commissioner wants to:

- Provide services which support victims of crime and reduce crime and disorder.
- Work in partnership to improve criminal justice outcomes and enhance community safety.

The voluntary, community and social enterprise sector has a crucial role in reducing crime and promoting safety within Suffolk communities.

Below are two of the notable projects funded:

The Forward Trust Programme received a £20,000 grant to offer recovery and reintegration services at Hollesley, Warren Hill and Highpoint prisons.

The programme prepared offenders for release through developing social skills workshops, improving mental/physical health. 98% of those involved in the project have not reoffended.

Room 4, Therapeutic Services for Young People was awarded £7,000 to support trauma-based therapy sessions in Haverhill for those at risk of gang affiliation, County Lines and Child Sexual Exploitation.

The programme supported 27 at-risk young people, offering 644 hour-long individual sessions which were provided over 46 weeks. The programme resulted in a 70% decrease in traumatic effects of crime.

How the Police and Crime Commissioner's Fund Works

Suffolk Community Foundation manages the PCC fund and applications, which are then considered by the PCC Fund Panel on a quarterly basis.

Members of the Panel include the PCC and Chairs of the county's three Community Safety Partnerships.

If your organisation helps to address and support the key areas in the Police & Crime Plan, you are encouraged to apply to the fund. In your application, you will need to demonstrate:

- A collaborative, partnership-working approach
- Projects targeted for hard-to-reach groups
- Gaps in services
- Clear, measurable outcomes.
