

Suffolk Police & Crime Commissioner's Fund Data Report

July 2022 – June 2024

About the Suffolk PCC Fund

The Suffolk Police & Crime Commissioner's Fund provides grants of between £2,500 - £20,000 to support the work of voluntary, community and social enterprise organisations and parish councils that are delivering services to help make Suffolk a safer place to live, work, travel and invest in. Multi-year funding has also been available for organisations who have previously received a PCC grant and provided satisfactory monitoring.

A total of **£541,899** has been awarded from the Suffolk Police & Crime Commissioner's Fund through **34 grants** from July 2022 to June 2024, making a meaningful impact **2333** beneficiaries, with a further **4153** expected to benefit from grants awarded but yet to complete. To avoid reporting on beneficiaries more than once, only 'estimated' beneficiary numbers have been used for grants yet to complete their end of grant report. 'Actual' beneficiary numbers will be included for these grants in subsequent annual reports. The estimated cost per head is **£83.55** (includes actual and estimated beneficiary data). The average grant size awarded was **£15,938.21**.

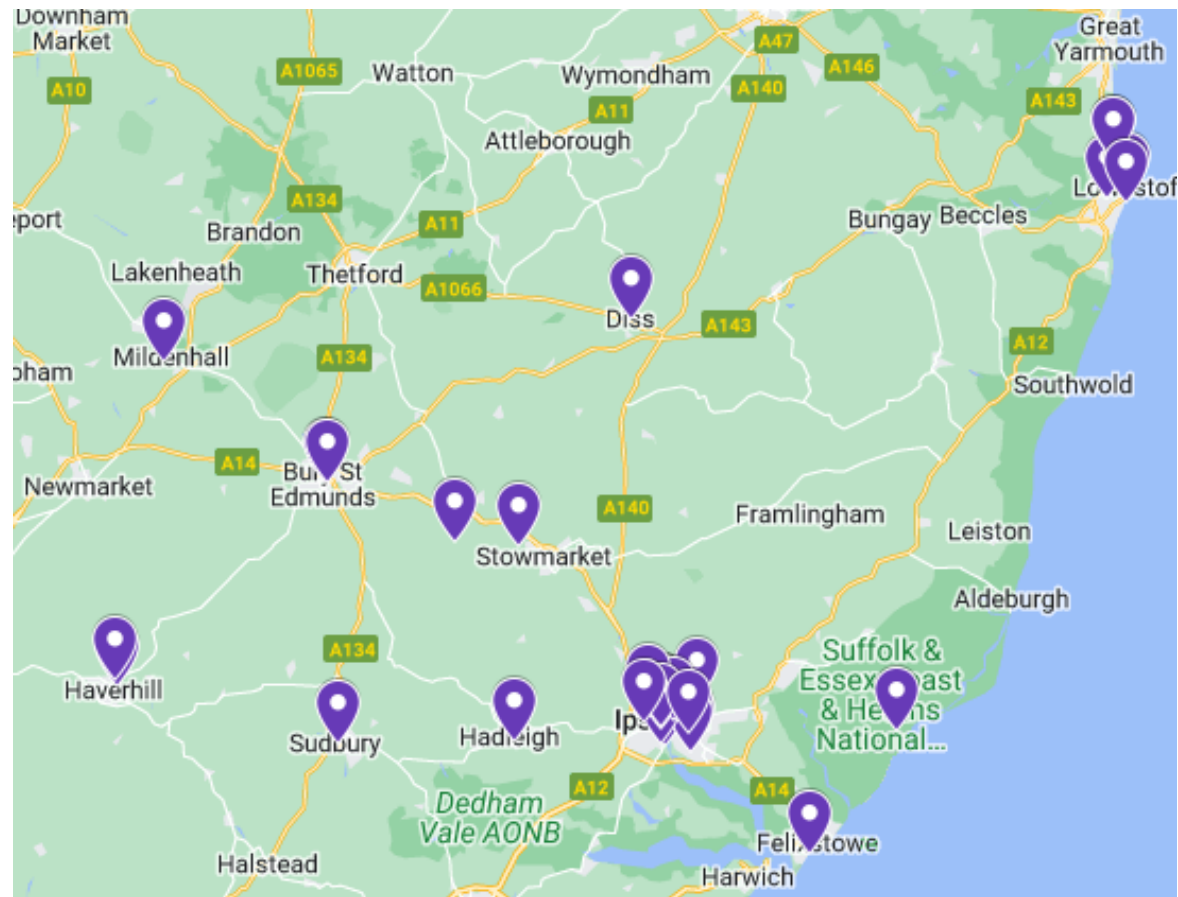

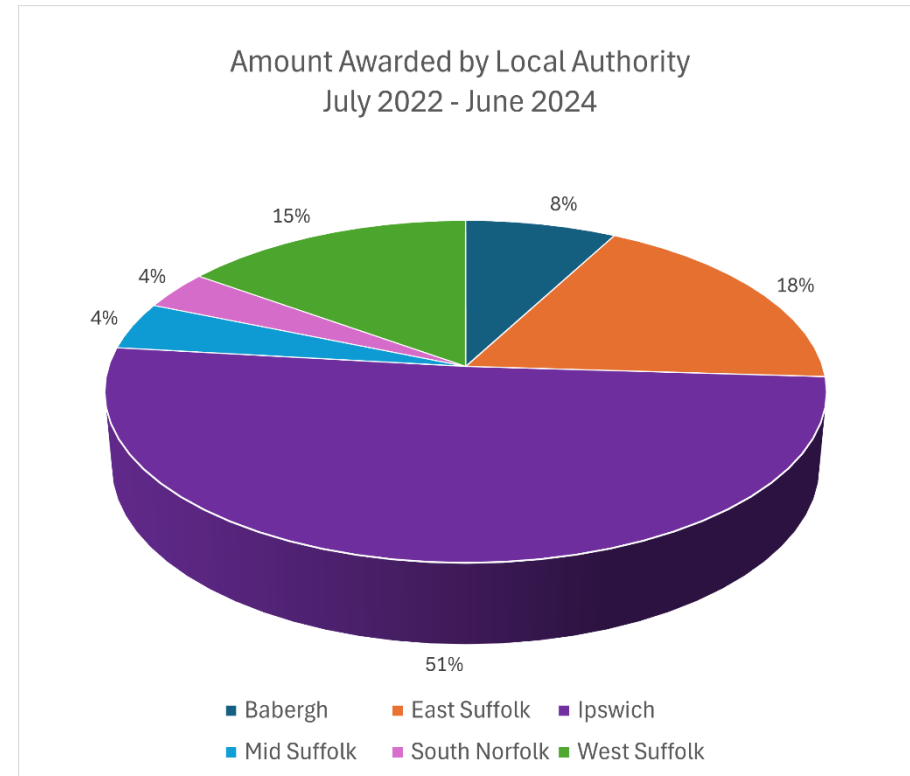

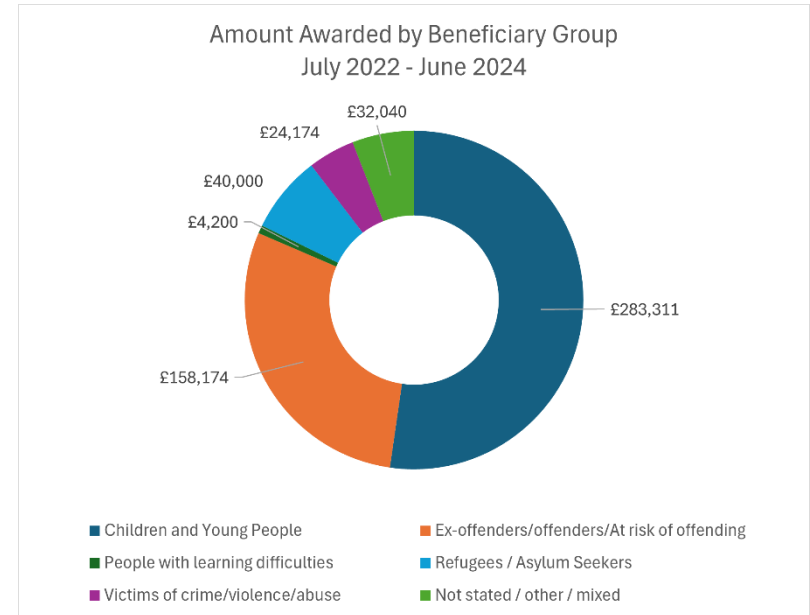

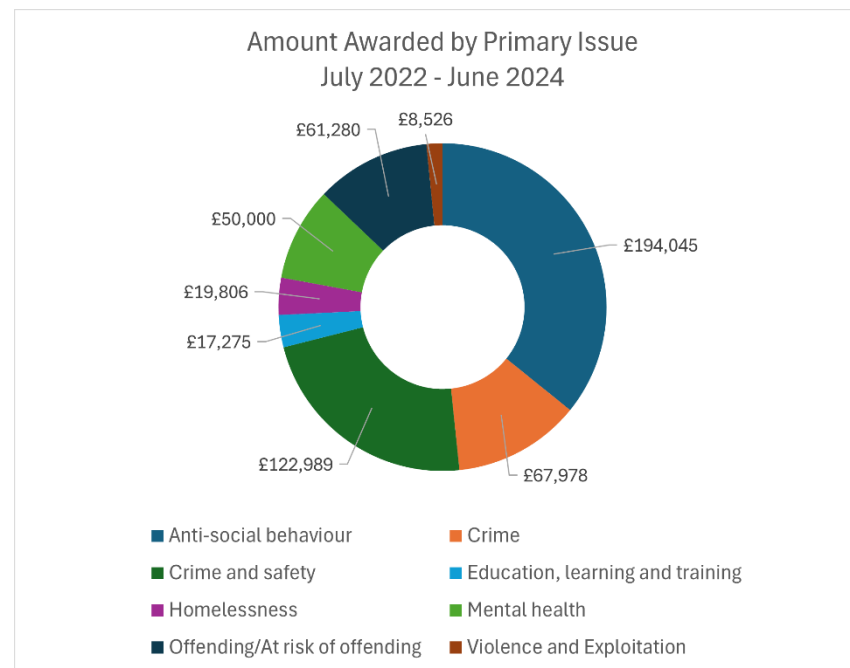

Projects identify their primary beneficiary group but may work with more than one group. Projects working with Children and Young People as their primary beneficiaries received the highest percentage of funding awarded (52%) followed by Ex-offenders/offenders/At risk of offending (29%).

Projects working to reduce anti-social behaviour received the highest percentage of the funding awarded in this period (36%). The same percentage went to projects working in crime & safety/crime (jointly 36%), followed by projects working to reduce offending or risk of reoffending ((11%).

Every organisation awarded a grant via the PCC Fund provides an end of grant monitoring report and where appropriate for multi-year funding also an interim report on the specific activities and outcomes achieved through the grant period. These reports are reviewed by Suffolk Community Foundation and an Impact Report on their activities and impact is provided to the Office of the Police and Crime Commissioner.
